The Government of the Republic of Zambia *has applied for* financing from the African Development Bank toward the cost of the Lobito Integrated Corridor Development Project (Upgrading of Mwinilunga to Jimbe (T005) Road) and intends to apply part of the agreed amount for this *loan* to payments under the contract for Consultancy Services for the Construction Supervision Services for the Upgrading of approximately 105km of the Mwinilunga to Jimbe Border Road (T005) in the Northwestern Province Of Zambia. Disbursement and payments, in respect of the contract signed, will be subject to the approval of the financing by the Bank.

The services included under this project are construction supervision services for the upgrading to bituminous standard of approximately 105km of the Mwinilunga to Jimbe Border Road (T005), lot 1 and 2, whose scope of works will include widening of the existing road formation to allow for a paved cross-section geometry to 11m wide road section, which will have 2 x 3.5m carriageway width and 2 x 2-m wide shoulders.

The duration of the assignment is 30 months (with a Defects Liability Period of 36 Months).

The Road Development Agency (RDA) now invites eligible consultants to indicate their interest in providing these services. Interested consultants must provide information indicating that they are qualified to perform the services (Company brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultants may constitute joint-ventures to enhance their chances of qualification.

Eligibility criteria, establishment of the short-list and the selection procedure shall be in accordance with the African Development Bank's *as specified in the Bank's Procurement Framework, dated 2015*, which is available on the Bank's website at <https://www.afdb.org/en/projects-and-operations/procurement/new-procurement-policy>.

A Consultant will be selected in accordance with the Quality and Cost Based Selection method set out in the Procurement Policy.
