1. Purpose of Notice

This Early Market Engagement (EME) notice is issued to inform potential contractors, consultants, and suppliers of the upcoming procurement opportunities under the Transport Corridors for Economic Resilience Project (TRACER). The Road Development Agency (RDA) jointly with the Ministry of Commerce Trade and Industry, with support from the World Bank, intends to undertake the following:

- (i) Rehabilitation of the Serenje to Mpika Road a strategic link under the Kapiri Mposhi (Zambia) to Dar es Salaam (Tanzania) Corridor (Packages 1 and 2); and
- (ii) Upgrading of the Nakonde One Stop Border Post Infrastructure.
